Why do we need to process your personal information / what is the purpose of personal data?

The purpose of a Privacy Policy is to inform individuals about the collection, use, and protection of their personal information by an organization or website. It serves as a transparent and accountable framework that outlines how the organization handles and safeguards user data, ensuring compliance with applicable privacy laws and regulations.

A Privacy Policy is a legal document that establishes a contractual relationship between the organization and the individuals whose personal information is being collected. It sets out the rights and obligations of both parties concerning the handling of personal data, fostering trust and confidence among users.

In summary, the purpose of a Privacy Policy is to provide individuals with transparent information about how their personal data is collected, used, and protected. It establishes a framework for legal compliance, consent, and accountability, while fostering trust and confidence between the organization and its users.

THE KEY PURPOSE OF A PRIVACY POLICY INCLUDE



- A. Transparency and Information: A Privacy Policy aims to provide clear, concise, and easily understandable information about the types of personal information collected, the purposes for which it is collected, and how it is used. It also informs individuals about their rights regarding their personal data.

§ We Stockholm Riders Cricket Club (SRCC) will ensure transparency and promote open communication, regular updates, and clear documentation to maintain club transparency and ensure keeping all members well-informed only maintain transparency and information flow within the organization.

§ We are the registered club under the Riksidrottsförbundet, the RF is the Swedish central sports authority task is to support, represent, lead, and coordinate the sports movement in common issues, both nationally and internationally. All the registered club bound to follow RF-SISU laws which refers to sports movements. The Club also processes personal information to apply for contributions or grants from, among other things, the Riksidrottsförbundet and the municipality.

§ The purpose of processing of personal data that usable in various areas for the club activities. We do need your data to hold your membership in the club, club administration purpose, to register and each training or match or tournament activities, application for the grants or projects, licence management, publication of materials on the club official website and social media, course, and training purpose.

*§ We would like to ensure you that SRCC will not share any of your personal data without your consent. We will **not** share your personal data with any third parties. Your personal data will be exchanged only with § RF / SCF / Municipality based on the Swedish Sports Confederation's (RF) policies.*

- B. Consent and Choice: Privacy Policies often outline how individuals can give their consent for the collection, use, and sharing of their personal information. They allow users to make informed decisions about sharing their data and offer options to exercise their choices, such as opting out of certain data processing activities.



§ Obtaining consent and admire individual choice to registering with SRCC ensures that participants willingly engage in club activities, fostering a sense of ownership, enthusiasm, and commitment. Publishing personal pictures requires explicit agreement and consent from the individuals involved to ensure their privacy and rights are respected §connect to application from.

- C. Security and Protection: Privacy Policies detail the security measures and safeguards implemented by the organization to protect the personal information it collects. - D. § Stockholm Riders Cricket Club known as SRCC is a registered member of RF-SISU, and SCF (Svenska Cricketförbundet). We acknowledge and embrace the responsibilities and obligations outlined by the General Data Protection Regulation, ensuring the protection and lawful handling of personal data by adhering to the rules, regulations, and directives set forth by GDPR, as well as embracing the club's code of conduct, we commit to upholding the highest standards of data protection and ethical practices [art. 1,5,6,7, 12.].

§ As part of our commitment to data privacy, the club conducts an annual assessment to determine if the processing of personal information remains necessary. If the purpose no longer persists, we ensure responsible data management by promptly deleting the relevant information, prioritizing the principle of data minimization, and maintaining compliance with applicable regulations.

§ To request the removal of your personal data from the club, please submit a formal request specifying the information you would like to be deleted.

- E. Cookie-and-Data Security: SRCC do not have inbuilt data management system which is referred visitor or user's login system. We hereby declare SRCC will not save any personal data from any users or visitors. Some cookie policies are defined below to customize our website:

H. Player Transfer Policy: SRCC general principles that are typically considered in cricket player transfers.

§ No Objection Certificate (NOC): In some cricketing nations, a player seeking to transfer may require a No Objection Certificate from their current cricket board or governing body. This certificate signifies that the board has no objection to the player's transfer and allows them to pursue opportunities elsewhere.

§ Consent of Player and Current Club: The transfer process should involve the mutual consent of the player and their current club. Both parties should be willing to engage in negotiations and agree upon the terms of the transfer.

§ Contractual Obligations: Players must abide by the terms and conditions of their existing contracts. Transfer requests should be made in accordance with any provisions or clauses mentioned in the contract, such as notice periods or buyout clauses.

§ Player Auctions: In some cricket leagues, player transfers are conducted through auctions. Players make themselves available for auction, and franchises or teams bid on them to secure their services for a specified period.

§ Transfer Windows: Cricket boards or leagues may have designated transfer windows or periods during which player transfers can take place. These windows provide a structured timeframe for clubs or franchises to negotiate and complete transfers.

§ No-Conflict of Interest: It is crucial to ensure that there are no conflicts of interest or violations of regulations during the transfer process. Any potential conflicts involving agents, team officials, or representatives should be carefully managed and disclosed to maintain the integrity of the sport.

§ Player Eligibility: Transfers should comply with the eligibility rules and regulations established by the relevant cricket boards or leagues. These rules may include criteria such as nationality, residency, or qualification periods for players to be eligible to represent a particular team or country.
